Whereas, Notification cited at reference adhering to the terms and conditions stipulated in the Government Notification cited at reference for selection of 20 Posts of Civil Police Constable Men and 05 Posts of Civil Police Constable Women was published in the Karnataka State Gazette on 14.09.2016.

Where as, the Recruitment Committee was conducted written examination to all the candidates on 06.11.2016 who were found eligible pursuant to the above notification

whereas, after conducting written examination the Recruitment Committee Conducted Physical standard Test & Endurance Test on 13.01.2017 & 30.01.2017 for eligible candidates in 1:5 ratio.

Whereas, as per the Notification cited at reference merit list was prepared by adding the percentage of marks obtained by the candidates in the written examination and in the qualifying examination Based on the merit and after taking into consideration the reservation of posts as in Notification cited at reference the First Provisional select List for the posts of Civil Police Constable Men and Women has been prepared and Provisional select list is published as under:

- A) This list is subject to the outcome of the results in the Medical Examination to be held by a Medical Board duly constituted by the Recruitment Committee.
- B) The Fact that the name of the candidates figure in the list does not give him/her any legal right for appointment to the post which will be dependent of the aforesaid condition.




